ADDENDUM WMR

WINGFOIL RACING MEDAL SERIES WITH REFEREES

Races may be sailed under the rules in Appendix WF including the rules in this addendum only if the notice of race and the sailing instructions so state.

WMR 1 PRINCIPLES OF REFEREEING

The protest committee may appoint referees, including protest committee members. Referees shall observe racing, initiate protests and give penalties without a hearing in accordance with rule WMR 3. A person with a significant *conflict of interest* shall not be appointed as a referee.

WMR 2 CHANGES TO THE RACING RULES

WMR 2.1 Rules 61.4(b)(1), (2), (3) and (5) rule WF 5 except WF 5 70.6 is deleted.

WMR 2.2 Wingfoils may not request redress.

WMR 2.3 Wingfoils may not protest another wingfoil, except if flag P is displayed at the finishing area.

WMR 2.4 When flag P is displayed at the finishing area, a wingfoil may protest another wingfoil, but not for an alleged breach of a rule of Part 2 unless she was involved in the incident. There is no requirement to inform the protestee, however she shall inform a member of a *committee* before flag B is removed from the finish line vessel.

WMR 3 ACTIONS BY THE PROTEST COMMITTEE AND REFEREES

WMR 3.1 When a protest committee or a referee appointed under rule WMR1 decide, based on their own observations, that a wingfoil has broken a rule and did not take an appropriate penalty, they shall penalize her without a hearing. Penalties shall be in accordance with rule WMR5.2 and WMR5.3.

WMR 3.2 A referee appointed under rule WMR1 may call a hearing to consider redress for a wingfoil based on their own observations.

WMR 4 SCORING INFORMATION

WMR 4.1 At the finishing line, the race committee will display each wingfoil's finishing place or score in the race, together with flag B and one sound. The scoring information and flag B will be displayed for at least one minute and removed with one sound.

WMR 4.2 When the race score of a wingfoil may be different to her finishing position, the race committee will display a yellow flag at the finishing area. The yellow flag shall remain displayed until all proceedings that may change a wingfoil's score are completed, or, if the race score of a wingfoil is, or will be, different to her finishing

position, until flag B is removed.

- WMR 4.3 If the race committee changes the scoring information while flag B is displayed, it will display flag L with one sound. The scoring information and flag B will continue to be displayed for one minute after any change is made.

WMR 5 PENALTIES

- WMR 5.1 A wingfoil involved in an incident may acknowledge breaking a rule for which she is not exonerated by promptly taking a penalty in accordance with rule WF44.

- WMR 5.2 If a wingfoil is penalized by a referee or protest committee, her penalty shall be either:

- (a) 1.1 points score penalty added to her race score or
- (b) disqualification from the race.

- WMR 5.3 A wingfoil will be disqualified when the referees or the protest committee decide that a wingfoil

- (a) caused injury or serious damage, or,
- (b) despite taking a penalty, either gained a significant advantage or caused a significant disadvantage in the race or series to another wingfoil by her breach, or
- (c) deliberately breaks a rule, or
- (d) commits a breach of sportsmanship,

The referees may report the incident to the protest committee for further action.

WMR 6 HEARINGS AND OTHER PROCEEDINGS

- WMR 6.1 No proceedings of any kind may be taken in relation to any action or non-action by a referee.

- WMR 6.2 The race committee will not protest a wingfoil.

- WMR 6.3 The protest committee may protest a wingfoil, or request redress for a wingfoil under rule 61.4(b)(4).

- WMR 6.4 The technical committee will not protest a wingfoil, except when it decides that a wingfoil or personal equipment does not comply with the class rules, rule 50, or the rules in the equipment regulations of the event, if such exist. The time limit for protests under this rule is the removal of flag B as described in rule WMR 4.1. The protest committee shall extend the time limit if there is a good reason to do so.

- WMR 6.5 (a) *Protests* and requests for redress need not be in writing.
(b) The protest committee may schedule the hearing, inform the parties of the time and place of the hearing, take evidence, conduct the hearing, and communicate its decision in any way it considers appropriate, which may be orally.

- WMR 6.6 A hearing shall not be reopened based on a request of a *party* to that hearing.
